Spring News Sheet 1967

It has been decided to keep members better informed by issuing a News Sheet in the Spring and Autumn of each year. This is additional to "Five Foot Three", which will continue to appear twice annually, with illustrations and matters of general railway interest in addition to news of the Society.

RAILTOUR

The May Railtour WILL RUN. Present bookings total about 150, so that even if a considerable additional number come in, the Society stands to lose over £100. It is fully realized that opinions differ over this tour; still you are asked to support it - thereby helping the Society's funds - even at this eleventh hour. You will have a chance to air your ideas about Railtours at the General Meeting on 12th May. Please have your booking in before 10th May, as we have insufficient staff to handle a last minute rush.

Lord O'Neill took the chair and gave an introductory address, followed by reports from the outgoing Chairman, Treasurer, Secretary and Railtour Organiser. Chief Topics were: publicity value of Meath Railtour; signing of lease for No.171; permission to work at Whitehead and the coming Dál Riada Railtour.

The question of the length of our sojourn at Whitehead was raised, whereupon, Mr J. Coulthard, NIR Managing Director, kindly promised to give us the longest notice he could of any closures. He also undertook to use his good offices with CIÉ with a view to railtours. He has met with some success and we are promised an interview with an Official from CIÉ Operating in the near future.

The proposal was accepted that no steps be taken in connection with Whitehead which would prevent our removal to another site.

Dublin and Portadown areas were formally approved and one representative of each appointed to the Committee. After discussion the office of Assistant (erstwhile Membership) Secretary was revived.

The Committee now consists of eleven members as follows:

L.H. Liddle (Chairman); E.F. Jordan (Honorary Secretary); J. Richardson (Honorary Treasurer); W.T. Scott (Honorary Assistant Secretary/Site Officer); D.J.A. Young and J.S.R. Harcourt (Joint Publicity); D. Henderson; A. Walsh (Locomotive/Dublin Area Representative); J. Glendinning (Portadown Area Representative); A.C. Robb (Railtours); A. Donaldson (Magazine).

After the elections discussion ranged over change of name of the Society, cost of distributing the magazine and special rates for Railwaymen. A General Meeting was promised for the Spring 1967.

WHITEHEAD

Though the lease is not yet signed nor its terms known we have been given informal permission to work and small parties have laboured on most Saturday afternoons.

The entire area has been cleared of undergrowth and the hut at the back repaired and fitted with a lock to serve as a store. Two short lengths of faulty rail were replaced but burning equipment is needed before the job can be finished.

Many sleepers need replacement but after a gang of members had spent a whole afternoon replacing one of them, p.w. work was suspended pending the acquisition of track tools. Member H. Frazer undertook to repair the shed doors and roof for cost of materials, but after £100 of work had been done it was found that re-roofing would cost some £700, compared with an originally estimated £200, because of the state of the trusses. This work also has been suspended till at least the May General Meeting. Lord O'Neill has supplied posts for fencing at cost price (2/9 each).

MOIRA

The National Trust, in a letter to Mr Jordan, expressed interest in our plans for this site and outlined their own. We hope to arrange a meeting with them to discuss the matter.

Mr E.V. Hill, NIR Chief Civil engineer, will supply turnouts at £90 and chaired sleepers at 15/- each plus a nominal charge for transportation and we shall probably purchase a quantity of these.

INSURANCE

D. Young would like to draw you attention to the following:

The Society has effected Public Liability insurance in respect of the site at Whitehead; also engineering policies are required to cover the locomotive boilers. Every member, upon his first visit to the site, will be required to sign an indemnity form to the effect that the Society will not be responsible for any injury howsoever caused. Should, through error, any member be overlooked he must request the form and sign it.

The policy does not cover injury caused by one member to another (i.e. one's personal liability) and the Committee ask every member to make sure he holds a personal liability policy. It is in your interest to do so; your insurance company will be able to supply you with this cover - premium is usually £1.

Also members are advised to make sure that they are covered for personal bodily injury - any insurance company will supply details. In the unfortunate event of injury the policy would supply additional income.

Much as the Society would like to effect a Group Personal Accident Policy in respect of workers at Whitehead, the cost is prohibitive at present.

SO REMEMBER - CHECK THAT YOU HOLD:

- 1) A PERSONAL LIABILITY POLICY and
- 2) A PERSONAL ACCIDENT POLICY

If you have neither form of policy you would be well advised to contact your insurance company and make immediate arrangements. Incidentally, of course, these policies provide vital cover all year round - not only for RPSI activities.
